For the purposes, concerned NITs shall ensure compilation and wide dissemination of information relating to the Participating Institutions, highlighting specifics in case of each of the Institutes, wherever necessary.

The other terms and conditions for smooth operation / functioning of CSAB-2023, DASA-2023, CCMT & CCMN-2023 will remain same as were conveyed vide this Ministry's communications issued for the previous academic year (2022-2023). All concerned NITs (as mentioned in para 1 above) will take necessary steps already enunciated and shall ensure proper scheduling and transparency of the admission processes including coordinating with NIC / NTA for the desired support.
