Online Registration	<p>One-time mandatory registration activity which includes the following:</p> <ul style="list-style-type: none"><li>Personal Details (including category selection, CIWG, SAARC, Non-SAARC etc.)</li><li>Contact Details</li><li>Passport Information</li><li>Qualification</li><li>Filling of Refund Details</li><li>Documents Upload</li><li>Fee Payment (Registration fee + Tuition fee)</li><li>Choice filling</li><li>Submission</li></ul> <p><b>NOTE:</b></p> <ul style="list-style-type: none"><li>Only those candidates who have filled and submitted the Registration form can participate.</li><li>Any candidate willing to participate in DASA-2024 UG admission process including the Special round must pay the fee here; it cannot be paid at later stage during any subsequent rounds. Moreover, the candidate is advised to pay the fee well before the last date (particularly in case of SWIFT, it is advisable to initiate fee payment well in advance before last date). DASA will not be responsible for any delays in receipt of fees in DASA account before the deadline.</li><li>Candidates <b>MUST “submit”</b> their saved choices. Candidates who do NOT submit their saved choices in the time window given, their last saved choices will be submitted automatically when the time-window for filling-in choices ends.</li><li>Once the fee is paid, applicants can withdraw their application, on or before the last date of the fee payment, and the full tuition fee will be refunded. He/ she can't participate in DASA special round.</li><li>However, will be automatically considered for Internal Sliding after the <b>FINAL allotment</b> round).</li><li>Accept &amp; Upgrade (Will participate in next rounds and considered for higher choices, but can't participate in DASA special round)</li><li>Decline: The candidate is exited from the whole counselling process including the special round. 13.	Online reporting to allotted Institutes for admission by the candidates who have been allotted a seat in Rounds 1, 2, 3 and FINAL.	This part is done by the Participating Institutes. The student has to join for an online meeting with the verification team at the allotted institute. The online meeting link will be provided by the allotted Institute through your(student's) registered email. You will be directed to provide your willingness for internal sliding / not for internal sliding / cancellation of admission. Choice refilling for Special Round	<p>The Candidates who are already registered but did not get any allotment till now are eligible for the choice refilling for Special Round against vacant seats.</p> <p>After candidate login in counselling portal, the candidate has to choose one of the following options:</p> <p>Participate in Special Round: - Candidate may opt this option to fill the choices. Candidates allotted a seat in special round will not be eligible for any refund.</p> <ul style="list-style-type: none"><li>• Exit:- Candidate may opt this if s/he doesn't want to participate in counselling. The candidate is exited from whole counselling process. The full tuition fee will be refunded as per refund rules.</li><li>• Please refer to DASA brochure for more details.</li></ul> <p><b>NOTE: Candidates participating in this round must 'submit' their choices.
